The management takes great pride in informing you that you have been appointed as SUPERVISOR in our organization w.e.f. 01/08/2018, presently posted at ~~Amritsar~~ branch. Your appointment shall be subject to the following terms and conditions:-

1. This offer will be initially for one month's trial, after which a probation for a period of six months and will continue to be until specially revised in writing by your confirmation. During the trial/probation period either side without notice can terminate your employment. However, this probation is liable to be extended further for a period of six months at the sole discretion of the Management. After confirmation giving one month's notice or one month's salary in lieu thereof, on either side can terminate your employment.
2. That on successful completion of your original or extended probation period, the Management shall consider your case for confirmation in service. You will be considered as confirmed in employment only on receipt of a written communication to you by the Management in this respect. In the absence of a specific written letter of confirmation issued to you, you will be considered to be on extended probation, except in case the Management decides to terminate your services. You will be informed appropriate.
3. That after completion of first three months in employment, whether you are still under probation/extended probation, in case you prefer to resign from the services of the Company, it will be in the sole discretion of the Management to relieve you immediately or not. Your resignation will become effective and final upon acceptance by the Management notwithstanding that the communication of the acceptance of resignation has reached you or not. However, it will be the prerogative of the Management to accept your resignation or not. In case of any misconduct on your part, your services can be terminated with immediate effect without assigning
