- Research is being promoted in the college. All the department are research centre and most of the faculty are research guides .There are 48 research scholars. some teachers are also indulge in research.
- Mentoring of the student is also a new system of the college in which all the teachers have assigned about 40 students. Mentoring System for students to minimize dropouts through Personal Counseling is evidence of success—better results in the Examinations, more regular attendance, increase participation in co-curricular activities, better discipline in campus and respectful relationship between teachers and students.
- Biometric attendance of the teachers has been introduced .
- Digital ID card (RFID Based)was issued to the students The College campus was made Wi-Fi enabled.
- Healthcare centre facility is also available in the college with the functioning of a first aid room.
- Library , the important aspect of the college, is efficiently enhancing library facility.As there is no permanent Librarian in the college, a Librarian has been employed on daily wages to run it well. Online resources are available in the college.
- The teachers are using ICT and Smart class rooms which have increased in numbers since first NAAC cycle.
- Free coaching for NET ,Civil services, SSC and other competitive exams are available in the college .Faculty of the college is providing the coaching to the students.
- Under the banner of MEDHA ,students are also getting training to face the interview .Placement will also be provided to the students.
- A Day care centre has been started by the college.
- College participated in NIRF.
- Availability of Internet and latest technological facilities are ensured for carrying out research work .All faculty members have been provided with unique user ID and password for accessing NLIST

- Beautification of the college ,Waste Segregation, Upgradation of infrastructure and seminar hall, audio video cameras ,installation of Solar Energy Panel , gymnasium are the major achievements of the college. Student union room, Electricity load enhancement are in pipeline,

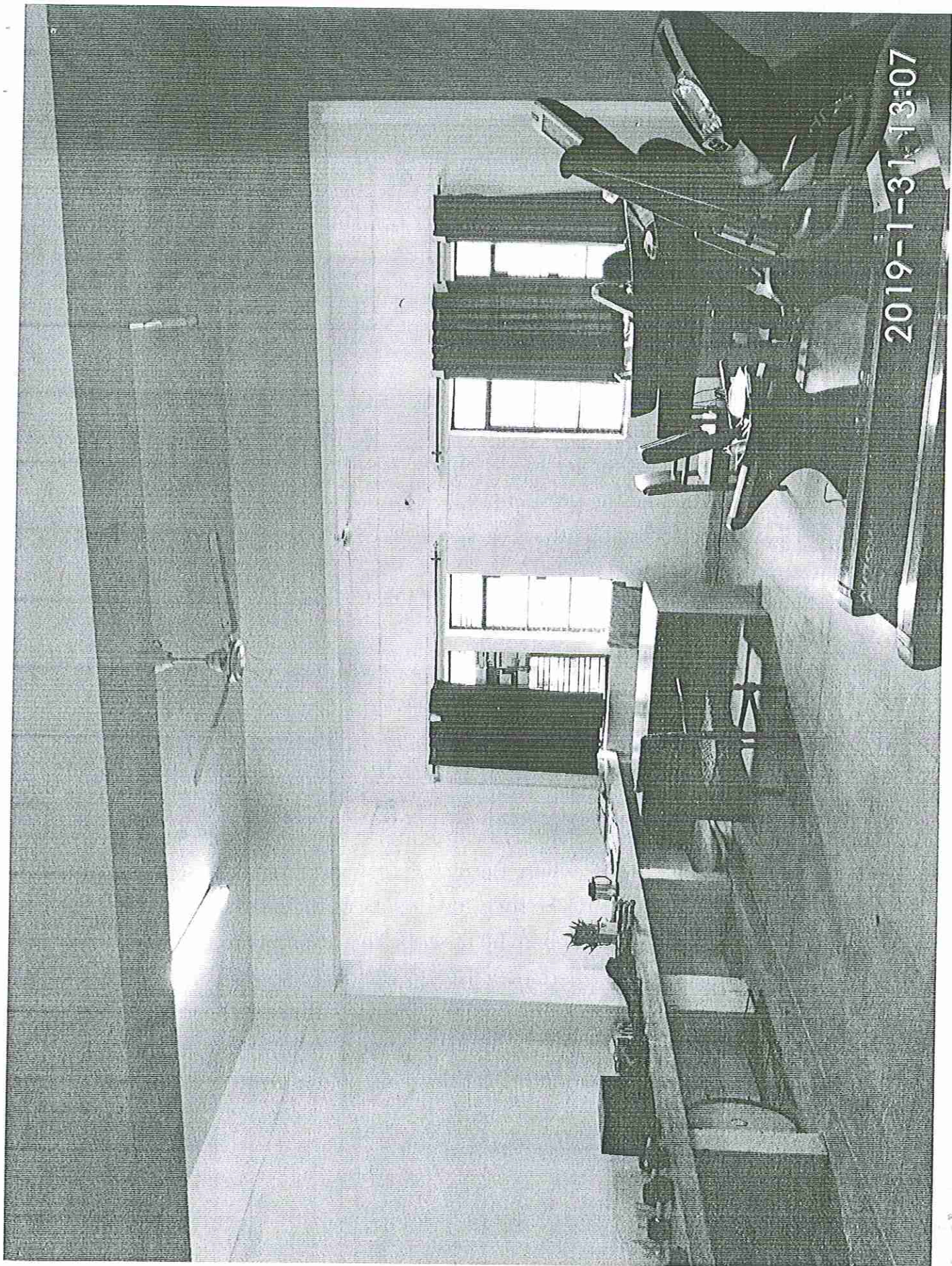

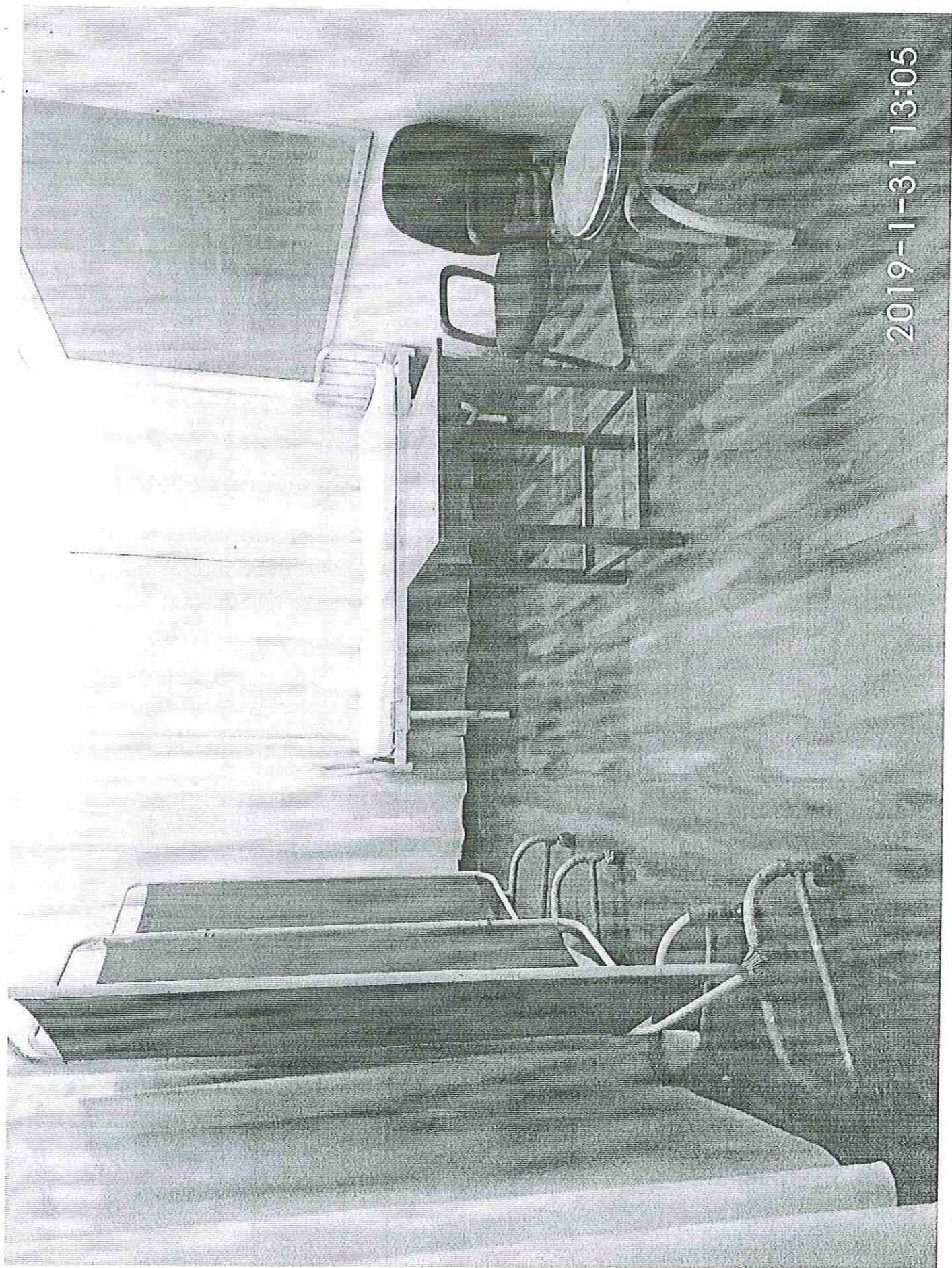
