COORDINATION

Both the institution shall appoint coordinator to coordinate programs on its behalf. Both the coordinator will periodically review and identify ways to strength cooperation between two institutes.

TENURE AND TERMINATION

This MOU will take effect from date it is signed by representatives of two institutions. It will remain valid for a period of two year. This MOU will be reviewed after one year: terms of this MOU may be amended by mutual written agreement prior to date of review. Any extension to this MOU will be formally agreed in writing by parties. Either institution may terminate MOU by giving written notice to other institution three month in advance and ensure that all activities in progress are allowed to complete successfully.

ARBITRATION CLAUSE

Should there be a dispute relating to any aspect of academic and co-curricular collaboration, head of both the institute will jointly resolve dispute in a spirit of independence, mutual respect and shared responsibility
