- विद्यापरिषद की बैठक दिनांक 26/02/2014 की कार्यवाही के मद संख्या 09 के निर्णय का अंश आवश्यक कार्यवाही हेतु प्रस्तुत है:- अध्यक्ष महोदय द्वारा उत्तर प्रदेश शासन के पत्र संख्या-नि.-05/सत्तर-1-2014 दिनांक 25/02/2014 विषय नियम 56 के अन्तर्गत माननीय सदस्य विधान परिषद डॉ० राधा मोहन दास अग्रवाल द्वारा दिनांक 25/02/2014 को दी गई निम्न सूचना को विद्यापरिषद के समक्ष प्रस्तुत किया "उच्च शिक्षा की विगड़ती स्थिति से पूरा प्रदेश मलौभाति परिचित है, अधिकांश विश्वविद्यालयों में पठन/पाठन की हालात खराब होती जा रही है, संसाधनों के अभाव, शिक्षकों की कमी, कुलपतियों की प्रशासनिक अक्षमता, परिसर में व्याप्त धष्टाचार, पुराने सौच से लदे हुए पाठ्यक्रम, छात्रों में शैक्षिक जागरूकता का अभाव एवं बढ़ती अनुशासनहीनता, आधुनिक विषयों के पठन-पाठन के प्रति प्रशासनिक अलसता, शिक्षा में व्यवसायिक उपादेयता के अभाव, शिक्षा और रोजगार के बीच समन्वय के अभाव, शासकीय स्तर पर नीति-निर्देशन के अभाव तथा अत्यधिक राजनैतिक हस्तक्षेप के कारण उच्च शिक्षा का पूरा ढांचा चरमरा गया है। व्यवस्था को सुधारने के प्रयासों में कमी तथा वैश्विक शैक्षिक व्यवस्था से जुड़ाव के अभाव ने छात्रों में उच्च शिक्षा का उद्देश्य सिर्फ डिग्री प्राप्त करना मात्र रह गया है। यदि प्राथमिकता के आधार पर सुनियोजित तरीके से परिवर्तन के भी संभावनात्मक हस्तक्षेप नहीं कि-ये गये तो स्थितियां बंद से बदतर होती जायेंगी।" तथा अपेक्षा की कि सभी संकायव्यवस्था अपने संकायों में संघालित पाठ्यक्रमों को अनुनातन करें तथा नदपजपेन करें, प्रश्नपत्रों की गुणवत्ता पर विशेष ध्यान दें, सुनिश्चित करें कि सभी यूनिट से प्रश्न पूछे जायें जिससे विद्यार्थी समग्र पाठ्यक्रम को गहनता से अध्ययन करें। यदि ऐसे प्रयास अनवरत जारी रखे जायें तो विश्वविद्यालय वैश्विक शिक्षण व्यवस्था के अनुरूप अपनी पहचान बना सकेगा।

जो भी मुख्य/सह परीक्षक नामित किये जाएं उनके फोन/मोबाइल नं० अवश्य दें। सह परीक्षक उत्तर पुस्तकों मूल्यांकन हेतु नियमित अथवा एस०एफ०एस० के हो सकते हैं जिनका तीन वर्ष का शिक्षण कार्य का अनुभव अपरम हो। प्राशिनकों एवं प्रोगात्मक परीक्षकों के पैनल के सीलड लिफाफे बैठक समाप्त होने के उपरान्त उसी दिन अतिगोपनीय विभाग को अनिवार्य रूप से हस्तगत करा दें एवं सह परीक्षकों के लिफाफे कार्यवाही/उपस्थिति पंजिका में एकेडमिक विभाग को उपलब्ध करा दें, अन्यथा की स्थिति में इसका उत्तर दायित्व सम्बन्धित पाठ्य समिति के संयोजक का होगा।

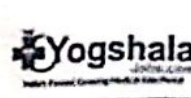
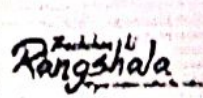


