And Between

Department of Sanskrit, KMGGPG College, Address - Badalpur, G. B. Nagar (through its Principal/Head of the Department (hereinafter would be referred as second party).

The main objective of this MoU is as under:



1. **Training and Internship of the students-** Both the institutions to provide training and internship to their students/interns as per objective of Skill oriented course under the guidelines of NEP-2020 and, a joint Certificate will be issued to the participants.
2. **Student Exchange programme-** Both the institutions to run Student-Exchange programme to their students for a short duration as decided by the Institutions mutually as per objective to fulfil requirements of Skill Course.
3. **Vocational/ Skill programme-** Students of both the institutions can participate in the Vocational/Skill programme run by them and their credits to be transferred as per U.P. Govt. norms.
4. **Student visits and Joint student activities-** Both the Institutions to organize visits for their students/interns, so that the students come to know the facilities and working of the institutions. Joint activities of the Institutions may also be organised.
5. **Exchange of faculties-**
Students of both the parties will be benefitted by exchanging the teaching/ training faculties, without any financial involvement.
6. **Developmental programmes-**
Participation/ collaboration of members of both the parties in different Training Programme, Extension activities, Exhibitions, International and national Seminars, Conferences, Workshops and other FDPs.



No party will be financial liable to another party for their services. However, if any student has damaged any goods etc, the respective party will take necessary steps for recovery of the Cost of damages.

6. Termination of Agreement:

The agreement may be terminated on the mutual understanding by giving two months' notice by any of the parties by giving adequate reasons.
