



Memorandum of Understanding

This Memorandum of Understanding is being signed between Prof. Piyush Chauhan, Principal, M.M.H. College, Ghaziabad (hereinafter called the First Party) and Prof. Divya Nath, Principal, KMGGPGC College, Badalpur (hereinafter called the Second Party) whereby it is mutually agreed as follows:

1. That both parties agree to enter into an MoU solely for academic purposes.
2. That both parties are aware that neither party will pay any students or faculty coordinators for participating in any internships, academic activities, site visits, etc.
3. None of the parties to this Memorandum of Understanding is subject to any financial obligations.
4. This Memorandum of Understanding aims to foster collaboration in geographical research between the two Departments of Geography. Dr Swati Thakur, Head & Assistant Professor, Department of Geography, MMH College, Ghaziabad and Dr. Meenakshi Lohani, Head & Assistant Professor, Department of Geography, KMGGPGC College, Badalpur will serve as the primary liaison between the two institutions to facilitate the development of future activities.
5. Dr. Uttam Kumar, Associate Professor, Department of Geography, MMH College, Ghaziabad and Kanak Kumar, Assistant Professor, Department of Geography, KMGGPGC College, Badalpur shall act as faculty co-ordinators for the execution of the above MoU.

Types of Cooperation

Through this MoU, both parties affirm to value interdepartmental inter-collegiate collaboration and agree to promote the following academic activities:

1. Joint research projects in the main fields of study.
2. Collaborative academic reports and publications that do not include conflicting interests.
3. Planning jointly organised seminars, conferences, and workshops.
4. Planning of student academic festivals.
5. Joint Geographical Field Trips.
6. Further actions decided upon by the signatories in mutual agreement.

Commencement, termination and amendment


This MOU will come into force from the date of affixing of the signatures of the representatives of the both institutions and will remain in effect for five years. If either organization wishes to terminate the MOU at the end of the five years period or in between the period of five years, it must notify the other organization not less than one month prior to the expiry of the MOU. The event of termination will not affect participants from completing their activities at the host party already initiated or ongoing unless otherwise mutually agreed. Modifications to MoU will be made by mutual consent and any amendment or extension to the MoU will be formalized by the exchange of letters and or emails between the two organizations.


Resolution of Disputes and Governing Law:


