



Memorandum of Understanding



This Memorandum of Understanding is being signed on the 8th day of February, 2023 between **Ms. Pragati Singh, Head & Assistant Professor, Department of Geography, Mihir Bhoj P. G. College, Dadri** (hereinafter called the First Party) and **Dr. Meenakshi Lohani, Head & Assistant Professor, Department of geography, KMGG PG College, Badalpur, GB Nagar** (hereinafter called the Second party) whereby it is mutually agreed as follows:

1. That both parties mutually agree to sign an MoU purely for academic purposes.
2. That both parties mutually agree that no stipend or remuneration etc., will be provided by either parties to students or faculty coordinators for undertaking any internship/ academic activity/ site visit etc.
3. None of the parties to this MoU is subject to any financial obligations.
4. The purpose of this MoU is to promote cooperation in conducting Geographical Research between both the Departments of Geography.
5. **Ms. Pragati Singh**, Head & Assistant Professor, Department of Geography, Mihir Bhoj P. G. College, Dadri and **Dr. Meenakshi Lohani**, Head & Assistant Professor, Department of Geography, KMGG PG College, Badalpur, GB Nagar, will serve as the primary liaison between the two institutions to facilitate the development of future activities.
6. **Ms. Pragati Singh**, Head & Assistant Professor, Department of Geography, Mihir Bhoj P. G. College, Dadri and **Dr. Kanak Kumar**, Assistant Professor, Department of Geography, KMGG PG College, Badalpur, GB Nagar shall act as faculty coordinators for the execution of the above MoU.

Types of Cooperation

Through this MoU, both parties affirm to value inter-departmental inter-collegiate collaboration and agree to promote the following academic activities:

1. Collaborative Research Projects in the thrust areas of research.
2. Joint Academic Publications and Reports with no clash of interests.
3. Organization of Joint Seminars/Conferences/ Workshops.
4. Organization of Academic Fests for students.
5. Joint Geographical Field Trips.
6. External Assessment of Skill based Vocational Courses.
7. Other activities as mutually agreed upon by the signatories.

Commencement, Termination and Amendment

This MoU will come into force from the date of affixing of the signatures of the representatives of the both institutions and will remain in effect for five years. If either organization wishes to terminate the MoU at the end of the five years period or in between the period of five years, it must notify the other organization not less than one month prior to the expiry of the MoU. The event of termination will not affect participants from completing their activities at the host party already initiated or ongoing unless otherwise mutually agreed. Modifications to MoU will be made by mutual consent and any amendment or extension to the MoU will be formalized by the exchange of letters and or emails between the two organizations.

Resolution of Disputes and Governing Law:

In the event of any dispute, matters not covered here in, any controversy or difference arising out of or in connection with this MoU, the same shall be resolved amicably by both the organizations. This MoU and further agreements will in all respect be governed by and construed in accordance with the laws of Republic of India.
